# NEW PRODUCTS OF INTEREST TO HAMS By Lyn, W3NSI

- 1. TS 430S KENWOOD i R: This compact new rig from the Kenwood company covers 160-10 meter bands on transmit and the receiver section covers the range 150 Khz to 30 Mhz. Unit is all solid state and rune 250 warts PEP on SSE, 200 Warts on CW, 60 Warts on AM and with the optional FM unit, which installs inside the case, 120 Warts. Eight memories store mode, frequency, and band information with a lithium battery backing up the memories. Scan circuits cover memory or can be programmed to scan band segments. Squelch is used on all modes. Other features include noise blanker, tuneable notch filter, speech processor, dual digital VFOs, and IF shift. Up/down tuning with push buttons is possible on either desk or hand microphones (optional) size 3 3/4" high and 10 3/4" square. Price \$900.
- 2. KENWOOD R2000 RECEIVER: The new R2000 does not replace the R1000; the 2000 is a more advanced unit which features band and memory scan (10 memories), all mode operation including FM, and all mode squelch circuit. Narrow or wide band filters can be selected for CW, or AM, with 15 KHz standard on FM. A 2.7 KHz filter is used on SSB and can be used on the narrow position with AM. A 500 Hz filter is a CW option at extra cost. Three tuning speeds are available at the push of a button. Frequency readout is a 7 digit fluorescent display. If you like push buttons, this R2000 is for you!!! Front panel contains speaker, 6 knobs, S meter and readout, plus 34 push buttons. Price \$600.
- 3. MOBILE MOUNT: Larson Electronics is selling a "Quik-Change" mobile mount that allows the user to remove the rig by sliding out of the two piece mount. No manual connections to disconnect. The power, speaker and antenna leads plug together as the mount pieces are re-connected. A lock is optional. Price \$36. Box C 11611 N.E. 50th Avenue, P.O. Box 1799, Vancouver, WA. 98668

## UHF/VHF REPORT By Jos, W2EIF

Theopenings on 6 meters have died down as they usually do in Jan. There were no openings during the Jan. WHF Sweepstakes to my knowledge. Activity prior to the contest indicated that a lot of people were preparing for and testing out rigs prior to the contest. There was a very good aurora opening; good through 432 Mhz on Sunday, January 10.

The contest itself in this area was not particularly effected by the adverse weather conditions - there was little snow compared to other areas and quite a few of us compiled scores at least 10% better than last year.

Six meters appeared down in activity, with a big jump in 2 meter action, and an increase also on 220, 432 and 1296. This may be partly blamed on the excessive number of football games on the weekend therefore a lot of six meter ops did not want to be on because of possible TVI.

The Pack-Rats have added a new net on Monday evenings. It is the 220 SSB net on 220.125 MHz at the low end of the band.

Have heard hints that the grid system as described in Jan. QST, P50. Will be used in some of the VHF coutests. Arguments have developed for and against. In my own opinion the bookkeeping and paper work is already an overwhelming task, so why add something to make it worse? It can only lead to decreased activity in something that should be fun. What are your thoughts on this.

## RANDY BYNUM UPDATE- FROM THE ARRL LETTER OF DECEMBER 21, 1982

To the complete surprise of the attorneys on both sides of the case, the N.J. Supreme Court has declined to hear an appeal by a radio amateur who contends that an RFI ordinance adopted in 1979 by Winslow Township, N.J., is pre-empted by the federal government. biggest part of the surprise is that court decided in March of 1982 to not hear the case. Yet it is only now that the attorneys have learned of the decision.

In December of 1979, Winslow Township adopted an ordinance which made it unlawful to "Transmit ... any radio emission, signal or transmission which either causes or creates electrical visual or audible interference, or, by said transmission annoys, disturbs or endangers the comfort, repose, health, peace, safety or general well-being of others within the limits of the Township ... The Township adopted the ordinance in response to pressure from neighbors of Randy Bynum, WB2SZK. According to the neighbors, Randy's operations on the six-meter band caused interference to television, stereo radio, intercoms, and other homeelectronic equipment. When FCC field engineers from the Commission's Philadephia office investigated, they informed the neighbors that the Amateur Station was operating properly. The engineers also suggested to the neighbors experiencing the interference that they contact the manufacturers of their electronic devices, explain the problem and request filters. The neighbors found this to be unacceptable, so they prevailed upon their township officials to pass an RFI ordinance.

Randy challenged the ordinance in N.J. Superior Court, lost on that level, and brought an appeal to the Appellate Division. In September 1981, the Appellate Division upheld the lower court, so Randy sought a writ of certiorari from the N.J. Supreme Court, hoping that the court would review the Appellate Division and rule in his favor,

### RANDY BYNUM UPDATE CONTINUED

All of this took place before the passage of the Goldwater Amateur Radio legislation. With the passage of this bill, now Public Law 97-259, there is no question that matters of radio frequency interference are preempted by the Federal government. In fact, Senator Goldwater's staff and the ARRL Hq. and General Counsel's staff worked the following language into the conferee report with the Bynum case in mind:

The Conferees believe that radio transmitter operators should not be subject to fines, forfeitures, or other liability imposed by any local or state authority as a result of interference appearing in home electronic equipment or systems. Rather, the Conferees intend that regulation of RFI phenomena shall be imposed only by the Commission.

Soon after the passage of this new law, Randy's attorney wrote to the N.J. Supreme Court, informing it of this dispositive development. That is when the Court informed the parties of its decision.

This means that as far as the courts in N.J. are concerned, the case is over unless Randy petitions for reconsideration and the court reverses its decision to not hear the case. Randy also has the option of going into a federal court and starting the whole procedure over, an option he is actively considering. However, Winslow Township has also seen Public Law 97-259, and it does not want to litigate the case any further. The Township is willing to settle the dispute by dismissing the criminal charges against Randy. Latest word from Randy is that he will consider that option only if the Township agrees not only to drop the outstanding charges against him, but also agrees to eliminate all antenna ordinances. We will keep you informed of any further developments.


